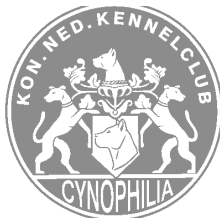

<p>For each entry from outside the Netherlands a certificate issued by a veterinary surgeon, stating that the dog has been vaccinated against rabies, 30 days of more, but not more than one year, prior to the date of the competition, must be obtained. Also a certificate, issued by a veterinary surgeon, not longer than 10 days before entering the Netherlands, stating that the dog is in good health and that the region of origin is free from rabies, must be obtained. The above mentioned certificates will be required before admittance to the competition.</p>			
<p>The exhibitor states that the dog he has entered – if born in the Netherlands after 30 April 1989, or in another country after the legal ban on cropping was in force there, or if born after 1 October 1996 in any country whatsoever – has not had its ears cropped. A dog that has had its tail docked and was born in the Netherlands after 31 August 2001 or abroad after the legal ban on cropping was in force cannot participate in the exhibition. Dogs with docked tails can participate in this show providing the docking was the result of a medical necessity. The statement concerning the required amputation has to be entered in the European animal passport by a practicing veterinarian. This statement should be made available for inspection during the exhibition.</p>			
<p>Dog owners must be capable of proving that their dogs are adequately vaccinated with standard vaccinations and a valid date.</p>
